Ink is expensive. That is a fact and there is not a whole lot you can do about it. However you can stretch your ink supply but trying changing how you use your printer. Most of us print pages for our own use. Since the page(s) we print are not going anywhere , why not print in draft mode? Draft mode is sometimes referred to as economode or quick print.

The text on the page is lighter than standard printing but again, it is for our use only. Check the properties of your printer and set the default mode to draft.

Changing the font you use can also help. Choose a thin-lined, san-serif font such as Arial or Calibri. In addition, use color sparingly. If your printing is mostly text, consider a simple monochrome laser printer

#### TELEPHONE DIRECTORY CALDWELL CROSSINGS

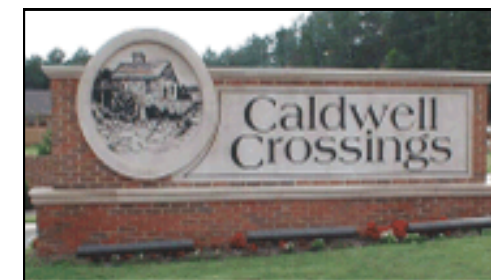

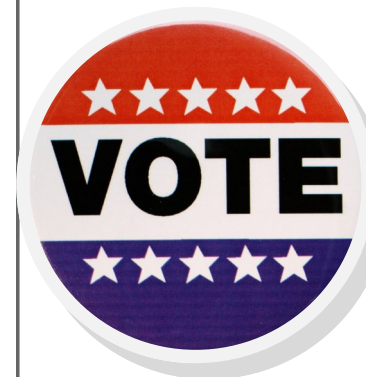

**Running at Large - Section 4-21 of the Municipal Code of the City of Hoover Alabama states:**

*"It shall be unlawful for the owner or person in charge of **an animal except cats and fowl to** cause or permit such animal to run at large or be upon a street, sidewalk, thoroughfare or public place within the city or its police jurisdiction, unless such animal is attached to a leash in the hands of said owner or person in charge of said animal."*

*"The owner of a dog, and any other person or persons in custody or control thereof, shall cause to be*

*removed any solid body excretions deposited by said dog on any property not owned by or in possession of the dog owner or the person or persons in custody and control of said dog at the time of said deposit."*

Our neighbor then asked what the Board could do about the cats that appear to roam at will throughout the neighborhood. While the C&R deals with this: **Section 6.19 of the C&R states: ` Dogs and cats shall not be allowed to roam unattended within the property `**

There is very little the Board can do as it is very difficult to match a cat with its' owner. However, we do encourage everyone to note if there are cats roaming freely and if you know who the owner is, notify the Board of Directors

**TRASH COLLECTION REMINDER**



Please help in keeping our neighborhood clean and neat looking. Some homeowners are putting trash bags and/or trash receptacles at the curb several days prior to pickup service. **When this happens on weekends, it is particularly unsightly to neighbors and guests visiting our area.**

Pick up service days are Tuesday and Friday for trash and Wednesday for recyclables. In accordance with Section 6.20(b) of the Caldwell Crossings Covenants, "trash cans and containers shall at all times be kept at the rear or inside a dwelling and shall be screened from view from streets and adjacent lots and dwellings by appropriate landscaping or fencing approved by the ARC, unless placed at the curb on the day of pickup by the waste pickup service for the Development."

Since trash pickup comes rather early, it is permissible to place trash bags and trash receptacles on the curb on the evening of the day prior to the pickup service. **Homeowners who use a lawn service company to maintain their yards should have the lawn service company take the grass and/or tree clipping with them or have them stored in accordance with the Covenant requirements.**
